Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that the Company has received on 10<sup>th</sup> January, 2025 an Order from the Office of the Commercial Tax Officer (ST), Pondy Bazaar Central-III, Chennai Central, Chennai, Tamil Nadu, demanding tax of Rs. 6.59 crores, interest of Rs.5.62 crores and penalty of Rs. 0.66 crore under Section 73 of the Central Goods and Services Tax Act, 2017 and Tamil Nadu Goods and Services Tax Act, 2017 for excess input tax credit availed in 2020-21. The Company is in the process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.
