Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that the Company has received an Order dated 29<sup>th</sup> July, 2024 on 13<sup>th</sup> August, 2024 from the Office of the Assistant Commissioner of Central Tax, Ameerpet G.S.T. Division, Hyderabad GST Commissionerate, Hyderabad, demanding tax of Rs.1.19 crores and penalty of Rs. 0.12 crore under Section 73 of Central Goods and Services Tax Act, 2017 and Telangana Goods and Services Tax Act, 2017 for the financial year 2019-20 for disallowance of input tax credit availed by the Company. The Company is in the process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.
