Pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, we hereby inform you that the Company has received an Order dated 6th July, 2024 from the Office of the Joint Commissioner State-Tax, Patliputra Circle, Patna Commercial Taxes Department, Bihar, demanding tax of Rs.0.46 crore, interest of Rs.0.19 crore and penalty of Rs.0.05 crore under Section 73 of Central Goods and Services Tax Act, 2017 and Bihar Goods and Services Tax Act, 2017 for the financial year 2021-22 for disallowance of input tax credit claimed by the Company. The Company is in the process of filing an appeal against the said Order. There is no material impact on the financials, operations or other activities of the Company due to this penalty.

The information as required under Clause 20 of Para A of Part A of Schedule III of the SEBI Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July 2023 is enclosed in the Annexure.
